**PRINCIPAL'S REPORT**

- a. An indoors in-person graduation ceremony is being planned for June 29, 2021. FFCA has 180 students graduating this year. How the ceremony will proceed will be determined by the Provincial restrictions at the time.
- b. There is a suggestion to do Grad Walk virtually this year. Gifts will be given to the grads from each campus.
- c. Students are doing online learning and will continue until May 25<sup>th</sup> unless advised differently by the Government.
- d. Mrs. Gerran will be retiring this year. Both campuses will need to hire new staff for the fall.
- e. North building permit process is ongoing. An open house was held with the Montgomery Community Association, Alberta Infrastructure to reveal the general design of the new building. We are on target to start demolition late fall.
- f. Diploma exams are optional. Teachers will be providing opportunity for reassessments.
- g. Provincial Assessment Tests Part A English were cancelled. Part B and Math will be held in June.
- h. Budget is in the process of renewal.
- i. Registration numbers: North campus – 493 students (short in grade 10) and South campus – 435 students (short in grade 9 and 10). Orientation will be provided for students on the waitlist.
